- 1. Call to Order:** Quorum was established at 3:14 pm
  - 2. Approval of Meeting Agenda for November 22, 2024**  
Director Shanoski moved to approve the agenda, Councilmember Taplin seconded the agenda. The motion passed 3-0

Councilmember Hahn was absent.

- 3. Approval of Meeting Minutes for September 20, 2024:**  
Director Shanoski moved to approve the agenda, Councilmember Taplin seconded the agenda. Director Chang abstained. The motion passed 2-1-0

- 4. Public Comment:**

- 5. Discussion Items:**
  - a. Traffic Safety at Cragmont Elementary**

Director Shanoski addressed multiple issues at Cragmont elementary around drop off and pick up times that have caused many concerns among families, to address this situation, she has met with families, Safe Routes as well the principal to implement a multi-pronged approach, which would include rolling drop-off and encourages family participation with incentives for kids. Director Shanoski requested City partnership to

implement the plan, to include traffic and parking enforcement. Councilmember Taplin shared his support for the initiative and proposed a month of enforcement, as well as periodic check-ins.

#### **b. Expanding Afterschool Programs**

Following the last meeting, there was a call for additional transportation support for elementary afterschool programs. Director Ferris proposed expanding the City-run programs, which serves 250 kids across four sites, but needs BUSD's help with busing. Director Shanoski suggested zoning afterschool programs to optimize transportation, though warned that BUSD is at capacity. Potential solutions include using electric buses and contracting additional services. Ferris agreed to explore zoning with the school district, targeting a review in May or June 2025. The presentation highlighted a 90% enrollment success rate and enrichment activities but noted staffing challenges, funding cuts, and the loss of COVID-related funding, necessitating thoughtful fee increases.

Councilmember Taplin emphasized the need to align City and school priorities, particularly around facilities and funding, and proposed a meeting next year to strategize collaboration. Director Shanoski suggested adjusting the fee structure to add a higher tier, as unduplicated students are decreasing while other families manipulate attendance policies.

City of Berkeley Director of Parks and Recreation Scott Ferris noted that in order to expand services or change bus routes, planning must begin by March or April, as July would be too late. Director Shanoski stressed the importance of coordinating with the Superintendent and Transportation, especially given ongoing construction at several sites.
